Cancellation and Refund Policy

1. Application fee is absolutely non-refundable.
2. Students may cancel their course before the program start date. In order to receive a refund for tuition deposit or the full amount of paid tuition, students **must** submit a "refund request" in writing (showing reasons for cancellation) and return the "original I-20" to Cal America within 30 days from the original program start date indicated on the I-20.
Tuition will **not** be refunded if a student cancels class after the indicated program start date or if the student fails to submit a written request and their original I-20 to Cal America within 30 days from the original program start date indicated on the I-20.
3. Students entering the U.S. using an I-20 issued by Cal America **must** complete three (3) consecutive sessions (or 12 weeks) with regular attendance before requesting a transfer to another educational institution. Any tuition amount for the first three (3) sessions (or 12 weeks) will not be refunded if students enter the U.S. with an I-20 from Cal America but fails to attend class. If the student has already paid for more than three (3) sessions but decides to finish his/her study earlier, any refund amount for the session(s) after the first 12 weeks will be calculated on a pro rated basis.
Refunds will not be applied to discounted rates.
4. The express mailing fee is non-refundable unless the course is cancelled before Cal America mails any documents to the student.
5. Students may cancel the housing placement service within 7 days from the day service is requested in order to receive a refund for the housing placement service fee. However, Cal America will deduct 30% of the paid service fee to cover expenses. There is absolutely no refund after 7 days from the day service is requested. Cal America will not refund the housing placement service fee for a cancellation request made after 2 weeks from the student's expected move-in date.
6. You may cancel the airport pick-up service 7 days before the date of your arrival in order to receive a full refund. Any refund requests made less than 7 days before your date of arrival will not be accepted.
7. All refund will be made in 6 weeks from the day Cal America receives written request from student. Students are responsible for all necessary expenses.

- ♦ You **must** submit the required **\$100.00** application fee and **\$200.00** tuition deposit along with complete application form in order for Cal America to process your application and issue I-20.
- ♦ You **must** also include **\$50.00** for express mail service fee with your application unless you can pick up your documents and I-20 -OR- if you can arrange to have someone to pick up your I-20 directly from our office during our office hours.
- ♦ Tuition shown anywhere on our brochure, information sheets, web site, or other printed materials does not include prices of textbooks and other class materials; and is subject to change without notice.
- ♦ If you are requesting housing service and/or airport pick-up service, you **must** also complete the Housing Application form and/or Airport Pick-Up Request and submit it to us along with appropriate fees.

*Housing placement service fee of **\$250.00** is a one-time service fee you pay Cal America to arrange housing for you. You **must** request housing placement service and pay full amount of service fee when you apply to Cal America or at least four (4) weeks prior to your move-in.*

*Airport pickup fee of **\$75.00** is a one-time service fee you pay Cal America to arrange one-way transportation from the Los Angeles International Airport (LAX). You **must** request the service and pay full amount of fee when you apply to Cal America or at least three (3) weeks prior to your arrival. Any request made during the last three (3) weeks prior to your arrival is subject to additional fee.*
